### 7 Approval of Minutes of previous meeting (16 May 2016)

#### 9 Community Police Officer's Report

There has been a significant reduction in fire-raising. In the last month police have carried out educational visits to local schools. During the weekend after Hibbs' victory they had to close 4 bars due to the large number of people, however on the whole the event was very successful with very few arrests. Recorded crime is down by 12% (figures are compared to the 5-year average) and violent crime down 5%. Alcohol offences are down to zero, but this is perhaps due to them no longer being reported. House breaking is down by 27% and non-dwelling house breaking up by 40%. The latter was mainly due to one person who has now been apprehended. A Police Surgery is being held every Wednesday between 12-2pm at McDonald Road Library and the police is happy to be contacted to train householders in crime prevention.

# 10 Presentation: TH Real Estates, developers of the new St James Centre

TH Real Estate, owners of other shopping centres in the UK, will spend an estimated £500 on the new St James Centre, which will comprise of 850,000sqft retail space, a 5\* hotel, 152 residential units and student housing. Demolition will start at this Autumn and will last for 14-16 months. Principal access to the St James Centre demolition/Quarter development will be via York Place, but with a dedicated service lane on Leith St. There will be holding areas for surplus lorries on Regent Rd. Spoil will be crushed in Granton, with new building elements prefabricated off site. Work will be carried out 6 days per week, weekdays 0800–1800 and Saturdays 0800-1200, using up to 200 lorries per day. There will not be any parking for staff on the premises. Picardy Place is likely to be redeveloped towards 2020 and it is envisaged that the tram will be part of its redevelopment. There will be 1500 parking places. John Lewis will continue to trade from this location.

The exact routes for construction traffic are still being planned using the Council modelling system. As this system has shown its shortcomings in the past, there were several CC members who voiced their concerns over this issue, particularly as the routes as they currently stand, are through often narrow and/or cobbled streets, with traffic jams more than likely.

Cllr Lewis Ritchie reported that Lidl are close to applying for planning permission for a store on the B&Q site in Easter Road with 78 parking spaces. As this would cause increased traffic he suggested Lidl should attend a future LCCC meeting.

Cllr Marion Donaldson reported that the Garden District Plan, a proposal to build over 1300 homes on Greenbelt land at the western end of the city, had been approved although she personally voted against it. She is currently looking at health provision in the ward and is visiting GP practices and she would welcome any feedback. She also reported that there are plans for another pedestrian crossing in Pilrig Street.
