¹ The revised guidance is intended to provide better locational clarity and ensure that regard is had to the character of each site's particular context, whilst continuing to promote or safeguard mixed, sustainable communities. This consultation gives LCCC an opportunity to influence downwards the amount of student accommodation. R McEwan stated that student accommodation cannot be converted to flats, while a resident stated that HMOs can be a costly option for students. D Giles stated that a building near Holyrood that had been planned as student accommodation but is now a hotel. B Ryan suggested that students should be accommodated in university-owned residences – privately-owned flats rented to students tend to be substandard.

² Spurtle 246: Three teenagers are sought in connection with a fire at the Haddington Place building site on 7 Oct. The lower-groundfloor blaze – started deliberately – caused £250k+ damage.

³ CEC guidance: at interim election at least half of the maximum permitted elected seats (16) must be filled, so at least 8 elected nominees. This would involve current elected members re-applying.

The timescale would be as follows: Nomination period – 3 weeks; Notice of Poll (if necessary) – 10 days after close of nominations; Polling day (if necessary) – 3 weeks from Notice of Poll.
