A – Police Report (September 2025) no police officer in attendance:

- Positives: Police working with youth workers on antisocial behaviour.
- Enforcement actions: drink driving, uninsured vehicles, zig-zag parking, seatbelt offences.
- Patrols: plain-clothes, on-foot on buses and trams.
- Illegal e-scooter use actively targeted.

Discussion:

- HT: Figures "indicative only"; comparative data missing.
- JM: Volunteers sought to compile stats none came forward.
- LH: Noted recent increased police presence on Leith Walk.

5. Open Forum (Residents & Businesses)

Powderhall Cycle Path:

- Raised by Alasdair Scott; poor cycle provision across Easter Road.
- Cllr Caldwell: Negotiations ongoing; Active Travel Fund application; slow progress noted.
- HT: LCCC campaigning since 2015; noted that CEC could negotiate more robustly.

Action:

• Cllr Caldwell to circulate T&E Committee paper to LCCC.

6. Planning

a. STL Policy

- Criteria: Objections for shared stair, contrary to NPF Policy 30E or City Plan 2030, non-consented operations.
- **Decision:** Adopted
- Proposed: AD
- Seconded: LH

b. LCCC Deputation to CEC Development Planning Sub-Committee re Club 3000 / Mecca Bingo Hall – 26 Manderston Street

- Charlotte Encombe, Cllr Caldwell, Cllr Dalgleish presented.
- Committee voted 6–5 in favour of 200 student beds.
- Action: Cllr Caldwell to keep LCCC updated.

c. Sandstone Building, Leith Walk

- CE/ HT emailed Adam Thomson regarding affordable housing obligations; reply awaited by next meeting
- JW suggested temporary football pitch use.
- Action: JW to write to Adam Thomson suggesting temporary community use.

d. CEC Planning Committee Papers (10 Sept)

- City Plan 2040: Key influence opportunity before adoption.
- Developer Contributions: Often missed; reference in objections.
- PBSA Guidance: Partial success; insufficient to block developments.
- Moratorium on PBSA: Motion not carried.
- Design Guidance: Adopted; non-statutory rules for listed buildings.

Actions:

- ACTION Planning Committee: Consider writing to Cllr Ashton with PBSA figures.
- ACTION SK: Circulate webcast link.

e. Cllr Caldwell Question on PBSA Appeals

- 9 refusals overturned in 5 years; 10th pending.
- Legal challenges discussed; members encouraged to write to MSP Ben Macpherson.
- Residents concerned about PBSA boom; risk of empty buildings.

7. Transport & Clean Streets

- HT shared this paper <u>Transport And Clean Streets Update</u>.
 - Parking: CEC running a Phase 1 survey on Controlled Parking Zones (Abbeyhill, Leith Walk/Pilrig, Leith/North Leith) open until 7 Sept. LCCC not submitting a formal response but keen to hear local cases of impact. Views can be submitted via this portal until 7 September
 - Service 13 Bus: LCCC survey shows mixed views valued by elderly residents and commuters for access to Craigleith, city centre, and cultural sites, but criticised for poor frequency, low uptake, and reliability issues.
 - Trams: Community Councils Together on Trams continuing to monitor resolution of outstanding works, with major issues due by Mar 2026 and integration of Edinburgh Trams into Lothian Buses planned to support unified ticketing.
 - TEC: Committee meetings now every 8 weeks (previously 4) broadly welcomed.
 - o **Cycle Hire Pilot:** Two-year city centre scheme launched in August, with retrieval of abandoned bikes charged to the operator.
- Real-time bus tracker: London Road stop resolved; 10 missing on Leith Walk; Cllr Caldwell following up.

8. Governance

- Replacement equipment chosen by residents.
- Artwork from old helter skelter to be installed.
- Maintenance Manager supportive of wildflower areas; fence removal planned.
- **ACTION** SP to circulate new *Park Life* magazine.

c. Dalmeny Street Park:

Harald raised concern over poor event notice;
ACTION: Cllr Caldwell to follow up.

10. Licensing

- Application 560227 (38–39 Elm Row) discussed; LCCC to object.
- ACTION: SK to submit objection.

11. Any Other Community Business

- Proposed LCCC Support for Victoria Primary School Astroturf access. AGREED
- Recognition of Gaelic School pupils' *Maes Mór* music video.
- SP asked about Elm Row cycle path markings and London Road planting; **ACTION:** Cllr Caldwell to follow up.
- JW: Noted the success of Stead's Place Street Party.
